# MEMBERS CREDIT UNION 2014 ANNUAL REPORT

This year, we are pleased to report that Members Credit Union has completed the construction of our newest location at 833 North Nolan River Road in Cleburne, Texas. What began in January 2008, with the purchase of three lots out across from the Cleburne High School campus, has now evolved into one of the nicest buildings in Cleburne.

Looking back over the past year, we began the building process with navigating the hurdles of the City of Cleburne's new overlay district requirements. We got to experience the process of replatting our three lots and the detailed building requirements of the City's Planning and Zoning Commission. Meetings with the SLI Group, our build/design firm out of Houston continued in January 2014. After several revisions we made to their architectural renderings, we were able to choose a floor plan that our Board of Directors felt would serve us well into the future. Additionally, we approved a new re-design of our logo that was incorporated into all advertising beginning in the fall of 2014.

The actual construction finally began on June 18<sup>th</sup> and for about a month there was a large pile of dirt on the airport side of the property. Some folks around town thought we were building a swimming pool, based on the size of the hole which had to be dug for our foundation. Once the dirt contractor was able to hit "bedrock" they began the process for laying a solid foundation which would set the course for the remainder of our construction project.

There were over 100 truckloads of concrete delivered to the jobsite during the course of the entire project. The vault was set in place on the 1<sup>st</sup> of September, and within a month the walls,

roof and decking were in place. By the end of October, the stucco and stonework were being installed. The cold north rains of November and December did not cause any serious delays, since by then, most of the work was being completed inside the building.

The beginning of the New Year brought more painters and finish carpenters into the interior of the building. The tilework and carpet was installed the last week of January. All of the furniture arrived during the first week of February and a Certificate of Occupancy was granted by the City of Cleburne on February 13, 2015. Arrangements were made with movers and our staff utilized the President's Day Holiday to move-in and set up their new offices over the long three day weekend.

The past year has gone by extremely fast, when looking back at the building process of this new facility. While the day-to-day pictures may not have shown much progress, the end result was well worth the wait. Our 60<sup>th</sup> Anniversary will be held in conjunction with our Grand Opening and Ribbon Cutting Celebration on April 2, 2015. We are very proud of this new facility and think it will serve our membership well in the years to come.
