Members Credit Union was founded by seven employees of the Santa Fe Railroad on September 8, 1954, when we began operations as Santa Fe **Employees Federal Credit Union. We continued to** grow and moved into 827 North Main in Cleburne. Texas in 1960. In 1968, we elected to convert from a Federal Charter to a State Charter and changed our name to Cleburne Santa Fe Employees Credit Union. When Santa Fe Railroad operations were moved out of Cleburne, the Board of Directors chose to expand our service offerings to anyone in Johnson County. In 1988, we changed our name to Johnson County Community Credit Union. In 1994, we changed our name to Members Credit Union to convey our member ownership, once a member - always a member - for life. In 2001, residents of Hood County were added to our field of membership. In 2006, a second branch opened at 1024 SW Alsbury Blvd in Burleson. In 2011, the H-F Employees FCU of Crowley merged into our credit union. In 2015, we sold the North Main location and moved to our present location at 833 North Nolan River Road in Cleburne. The seven charter members who began offering services from the Santa Fe Railroad yard offices, could not have imagined how this credit union looks - 71 years later.

At the time this report was being prepared, plans were underway to celebrate our 10th anniversary of the opening of our Nolan River Road location. It seems like time has flown by during these past 10 years.

As we look back over this past year, we wanted to let you know that 2024 was one of the best years in our Credit Union's history. If you consider the dramatic interest rate increases and the escalating costs of everything from groceries to houses, Members Credit Union maintained a conservative business plan which allowed us to surpass our initial goals and projections.

We exceeded the NCUA's "Well-Capitalized" minimum of 7.0% Capital, which underscores our financial strength. We ended this past year with a Capital ratio of 11.5% and Assets of over \$103 million dollars.

Additionally, we replaced the ATM at the Nolan River location with a model that now accepts deposits. We plan to replace the ATM on North Main Street with a model that will also accept deposits as well as install a new canopy surrounding the ATM. These improvements should be complete by the second quarter of 2025. The owner of that location has made improvements to the parking lot and driveway, which will make it very nice for our members who use that ATM location.

Our experienced staff have more than 275 years of combined service at MCU. I can assure you that we have the knowledge to answer whatever financial questions you may have. When you enter our offices, we will recognize you, and we will call you by name. We encourage you to come inside, sit down, and talk with one of us about your future financial plans.

We continue to seek ways to help our credit union family navigate the financial changes that will certainly come in this new year. Thank you for the trust you place in Members Credit Union and for allowing us to meet your financial needs.
