



## EACTS WHAT DOES MCU DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.		
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:  • Social Security number  • Payment history  • Checking account information  • Transaction history  • Wire transfer instructions  When you are <i>no longer</i> a member, we continue to share your information as described in this notice.		
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons MCU chooses to share; and whether you can limit this sharing.

Who is providing this notice?	MCU means Members Credit Union.
What We Do	
How does MCU protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does MCU collect my personal information?	We collect your personal information, for example, when you  Open an account  Make a wire transfer  Show your driver's license  Give us your income information  We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.  • Our affiliates include:  • Financial companies such as: Vantiv
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.  • MCU does not share with nonaffiliates so they can market to you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Our joint marketing partners include credit card companies, insurance companies and investment companies.

## Other Important Information

For Alaska, Illinois, Maryland and North Dakota Members. We will not share personal information with nonaffiliates either for them to market to you or for joint marketing - without your authorization.

**For California Members.** We will not share personal information with nonaffiliates either for them to market to you or for joint marketing - without your authorization. We will also limit our sharing of personal information about you with our affiliates to comply with all California privacy laws that apply to us.

For Massachusetts, Mississippi and New Jersey Members. We will not share personal information from deposit or share relationships with nonaffiliates either for them to market to you or for joint marketing - without your authorization.

## For Vermont Members/Customers.

- We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
